I, the undersigned, hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a business organization for profit in accordance with the laws of the State of the State of Florida.

**ARTICLE I**  
**Name**

The name of this corporation shall be **WELL PRESSED EXPRESS JVP. INCORPORATED.**

**ARTICLE II**

**ARTICLE III**  
**Existence of Corporation**

This corporation shall have perpetual existence.

**ARTICLE IV**  
**Purposes**
