ARTICLES OF INCORPORATION  
OF  
**C&C BOBCAT & BACKHOE SERVICE, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I – CORPORATION NAME**

The name of this corporation is **C&C BOBCAT & BACKHOE SERVICE, INC.**

**ARTICLE II – COMMENCEMENT OF CORPORATION**

The existence of the corporation shall begin on May 1, 2000.

**ARTICLE III – PRINCIPAL OFFICE AND ADDRESS**

The street address of the principal office of the corporation is 30335 Rainey Road, Sorrento, Florida 32776.

**ARTICLE IV - PURPOSE**

The purpose of the corporation shall be to engage in the business of site work preparation and other related purpose.

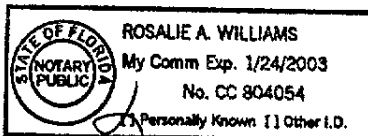


