*Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:*

1) **ARTICLE III, ARTICLE IV and ARTICLE X** are being amended to read as follows:

**ARTICLE III - CAPITAL STOCK**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is **500,000.00 (Five hundred thousand)** shares of common stock, each share having a par value of **\$1.00**. Said authorized shares may be divided in to voting and non-voting shares before issuance by action of the Board of Directors. However, in the event the Board of Directors does not specifically make such designation, said stock shall be deemed voting.

Authorized capital stock may be paid for in cash, services or property at a just value to be fixed by the Board of Directors of the corporation at any regular or special meeting.

**ARTICLE IV- INITIAL CAPITAL**

The amount of capital with which this corporation shall begin business is **\$5000.00 (Five thousand dollars)**.

**ARTICLE X - SUBSCRIBERS**
