To Whom It May Concern,

I am writing in reference to a refund of our Reinstatement fee of \$600.00 that we mailed in December of 2002. When we wanted to become a corporation, we hired Susan Marshal here in Pensacola to do the filing for us and as things went on, we thought that everything was ok and that we were a corporation. Come to find out that a paper, the 2553 was not signed properly and sent in . This affected us being a sub-s corporation with the IRS, but according to the state we were a corporation. We did not know this. So to make a long story short, we found out in 2001 that our corporation was dissolved and that we would have to pay a penalty because our UBR's were never sent in for 2000 and 2001. I, myself, have never heard of nor have ever seen what a UBR is until this past December 2002. I called your office and counseled with a lady there extensively and we got everything straightened out. I found out that we could ask for a refund if we never received the UBR's in the mail. As we were trying to find out why I never received any, I remembered that we have moved twice since then. I am thinking that what happened was that it was sent to me at the beginning of 2001 at the address that you have on file for me, which was the Gadsden St. address, and by that time we had already moved to White Oak St. We were only there for 6 months and then we moved to Schwab, were we currently reside. I found out that there is only a period of six months that the post office will forward mail to a new address. I am thinking that by the time the UBR made its way around the post office and Pensacola, that we had already moved to our current address. I am almost positive that it has gotten lost in the mail. As I said before, I have never known what a UBR is and have never seen one, until now. I know what they are now and am sending ours in for this year. I am sincerely hoping that we will be able to be refunded the \$600.00 we paid in as a penalty. I would greatly appreciate this.
