

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I.

The name of this corporation is R & B's Lawn Service and Specialties, Inc.

ARTICLE II.

The main location where the company shall conduct its business is 789 US 301 South, Lot 5, Jacksonville, Florida 32234.

ARTICLE III.

The duration of the corporation shall be perpetual.

ARTICLE IV.

The purpose of the corporation shall be to providing lawn, sod, tilling and sprinkler maintenance service installation and repair plus pressure washing, painting, carpentry, home restoration and housecleaning for the general public, business, and for any other lawful purpose for which corporations for profit are incorporated under the laws of the State of Florida.

ARTICLE V.

The method of election of directors shall be as stated in the corporate by-laws.

The name and address of the sole incorporator is Biana L. Rousselle, Route 24, Box 144, Baldwin, Florida 32234.

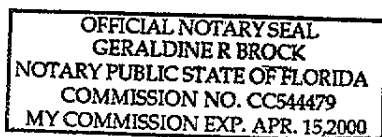


