

ARTICLE I - NAME

The name of this corporation is MR. QUICK, INC.

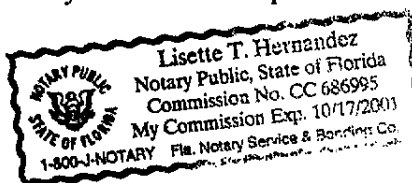
