ARTICLE I-Name

The name of this corporation is recruiterlink.net, inc.

ARTICLE II- Principal Office

The address of the principal office is 2928 Kenilworth Boulevard, Sebring, Florida 33870.

ARTICLE III-Duration

This corporation shall have perpetual existence.

ARTICLE IV-Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE V-Capital Stock
