ARTICLES OF INCORPORATION

OF

THE LEA BARR GALLERY, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE: NAME: The name of the corporation shall be THE LEA BARR GALLERY, INC.

<u>ARTICLE TWO:</u> <u>DURATION</u>: The term of existence of the corporation is perpetual.

<u>ARTICLE THREE</u>: <u>PURPOSE</u>: The purpose is to engage in any activities or business permitted under the Laws of the United States and Florida; including but not limited to, the operation of an art gallery.

ARTICLE FOUR: CAPITAL STOCK: The corporation is authorized to issue one hundred (100) shares, all of which shall be common shares, no par value.

ARTICLE FIVE: INITIAL REGISTERED OFFICE AND AGENT: The street address of the initial registered Office of the corporation is 200 A1A, Unit 3, Flagler Beach, Florida 32136, and the name of the Registered Agent is LEA BARR, of 200 A1A, Unit 3, Flagler Beach, Florida 32136. <u>ARTICLE SIX</u>: <u>INITIAL BOARD OF DIRECTORS</u>: This corporation shall have two (2) directors initially. ARTICLE EIGHT: BY-LAWS AND ARTICLES OF INCORPORATION: The shareholders shall have the exclusive authority to formulate, approve, and/or amend by-laws of the corporation and shall have the exclusive authority to formulate, approve, and/or adopt these amendments to these Articles of Incorporation.

<u>ARTICLE NINE</u>: <u>COMMENCEMENT OF EXISTENCE</u>: The corporation shall be deemed to commence its existence upon the filing of these Articles in the Office of the Secretary of State of the State of Florida.
