The undersigned, acting as incorporator of a Corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME AND ADDRESS

The name of this corporation is Jellyfish U.S., Inc., and the street address and mailing address of the initial principal office is 587 Plantation Drive, Port St. Joe, Florida 32456.

ARTICLE II - PURPOSE

This corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.


