**ARTICLE I NAME**

The name of this corporation is ROBERT J. CAPKO, P.A.

**ARTICLE II DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

**ARTICLE III PURPOSE**

This professional service corporation is organized for the purpose of :

1. Providing Legal Services;
2. Transacting any other lawful business for which corporations may be incorporated under Florida law; and
3. Doing such other things as are incidental to the foregoing or necessary or desirable to accomplish the foregoing.

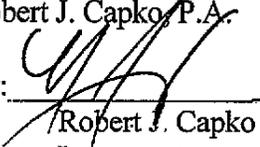
## ARTICLE IX INDEMNIFICATION

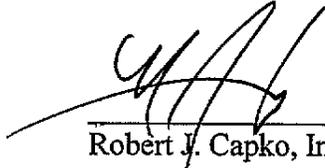

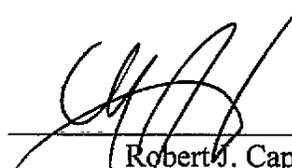
