Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is **BLUESTANDARD.COM, INC.** (the "Corporation"), Charter #P00000040858, filed on April 24, 2000.

2. The following Amendment to the Articles of Incorporation was adopted by the sole Director of the Corporation on May 25th, 2000 in the manner prescribed by Section 607.1002 of the Act: Shareholder approval was not required.

"ARTICLE III

The Corporation shall have the authority to issue One Million (1,000,000) shares of Common Stock, \$.001 par value per share."

3. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.
