ARTICLES OF INCORPORATION

OF

MANGROVES of Cape Canaveral, Inc

ARTICLE I - NAME

The name of the corporation is MANGROVES of Cape Canaveral, Inc.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

ARTICLE VII - INITIAL REGISTERED OFFICE AND AGENT
