The filing fee for a Florida profit corporation is currently \$150.00. This fee only applies to corporations who file on or before the May 1, 2006 filing deadline. All filings received by the Florida Department of State after May 1, 2006, will be subject to a \$400.00 late fee in addition to the \$150.00 filing fee for a total of \$550.00.

Please be sure to include a check made payable to the Florida Department of State in the amount of \$150.00 (check must be payable in United States Funds and through a United States Bank) when you submit the Report for processing. If you have elected to make a campaign contribution or requested a Certificate of Good Standing, you will need to add those charges to the filing fee. Again, the Report must be filed on or before May 1, 2006, to avoid penalties and, eventually, involuntary dissolution by the State. If the corporation is dissolved by the State for failure to file the Report, there will be substantial reinstatement fees due to reinstate it.
