ARTICLES OF AMENDMENT

## TO THE ARTICLES OF INCORPORATION OF

## LIMNI, INC.

The undersigned, certifies that:

- 1. She is the President of LIMNI, INC., a Florida corporation, whose Articles of Incorporation were filed with the Secretary of State, State of Florida, on April 20, 2000.
