

**ARTICLE I - NAME**

The name of this corporation is Altec Screens, Inc.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date these articles are filed with the State of Florida.

**ARTICLE III - PURPOSE**

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

**ARTICLE IV - CAPITAL STOCK**

This corporation is authorized to issue 1,000 shares of one dollar (\$1.00) par value common stock, which shall be designated "Common Shares".

**ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT**

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, in accordance with the provisions of the Florida Business Corporation Act.


**ARTICLE XIII - AFFILIATED TRANSACTIONS**
