ARTICLES OF INCORPORATION

OF

The Auto Weatherstrips.com Corp

In compliance with Chapter 607, F.S., Florida Profit

ARTICLE ONE

The name of the corporation is The Auto Weatherstrips.com Corp

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE
