ARTICLES OF INCORPORATION

FOR

INNER CONNECTIONS, INC.

ARTICLE I - NAME

The name of this corporation shall be Inner Connections, Inc.

ARTICLE II - DURATION

The duration of the corporation shall be perpetual.

ARTICLE III - PURPOSE

The following are the purposes for which this organization has been organized:

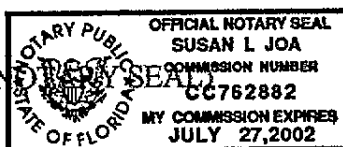
