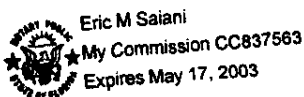
1. Calvin W. Isaacson is the President of PMI INVESTMENTS, INC., a Florida Corporation, (hereinafter "Corporation").
