COAPRE, ED The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I CORPORATE NAME

The name of the corporation shall be Mare & Goldstein, Inc., and the corporation's principal address shall be 3640 Terrapin Lane, Coral Springs, Fl. 33067.

ARTICLE II TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE III NATURE OF BUSINESS AND POWERS
