PLAN OF MERGER FOR MERGING MARBELLA DEVELOPERS, LLC PARAMOUNT QUALITY HOMES CORP.

This Plan of Merger is made this 13 day of June, 2005, by and Between Marbella Developers, LLC, a Florida limited liability company, ("Merging Entity") and Paramount Quality Homes Corp., a Florida corporation, ("Surviving Entity"). The Merging and Surviving Entities are sometimes referred to in this Agreement as the "Constituent Entities."

ARTICLE I
