**ARTICLES OF INCORPORATION  
OF

The undersigned, for the purpose of creating a corporation under the laws of the State of Florida, does hereby adopt the following Articles of Incorporation:

**ARTICLE FIRST--NAME OF CORPORATION**

The name of the corporation is All Commercial Sales, Inc. The principal office of the corporation is located at 1905 Sharon Road, Tallahassee, Florida 32304.

**ARTICLE SECOND--DURATION**

The duration of the corporation is perpetual, unless sooner dissolved by the officers or shareholders as provided for by the laws of Florida.
