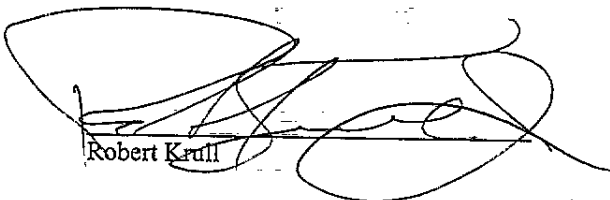
ARTICLE IX. AMENDMENT

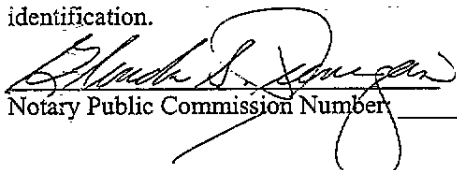

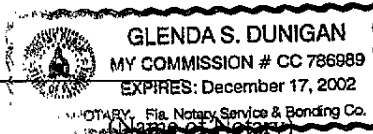

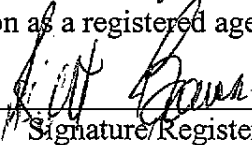
