ARTICLE VI. AMENDMENT


This corporation reserves the right to amend or repeal any provisions contained in these

ARTICLE VII. INDEMNIFICATION


The Corporation shall indemnify any person to the fullest extent permitted by the Florida Business Corporation Act.



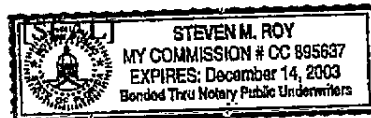
