

ARTICLE VI



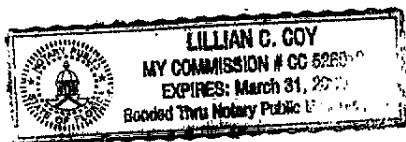
