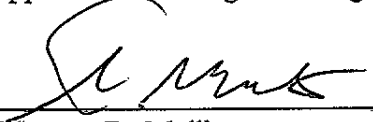

Article X – Indemnification by Corporation

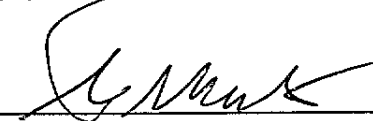
