

Modular Motion Systems, Inc. is a first year corporation in Florida as I was incorporated in Illinois previous to my new residency now in Florida.

I did not receive the first billing for the corporation fees as I have a good credit record and pay fees and bills as they are received.

My circumstances conveying non-receipt of this billing are as follows:

I have included a photo of my re-mounted metal mailbox at 1395 Leland Way (address corporate correspondence is sent to). This was necessary as the mailbox was knocked down by vandals. The box is now mounted from one side as the original center mount was destroyed as it was knocked down.

Secondly, my original plastic mailbox was also vandalized (actually competely removed) such that I replaced it with a new metal box referred to above nearer the beginning of the year.

Attached is an article in the local newspaper documenting this problem we have on Marco Island. This has been a recurring problem.

The likelihood of not receiving the billing along with my good record of payment of obligations are thus now documented.

My first correspondence concerning non-payment considered that you may have sent this bill to the registered representative (my attorney Ron Webster) where it would not have likely been forwarded to me for payment (corporate correspondance in Illinois does commonly go to the registered representative.) You indicate you do not send these to the registered representative and also checking with my attorneys office this is the case.

My multiple calls to your office have been met with suggestions to send this history and reasoning for why I did not receive the billing and they did not suggest that my penalties will keep increasing as I try to receive resolution of this matter.

I kindly ask for your consideration in this matter as the reasons conveyed are significant to indicate circumstances that are evident for the not receipt of the billing documents. I have paid the \$150 fee with past correspondence.
