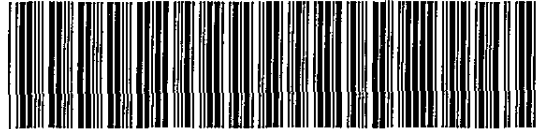

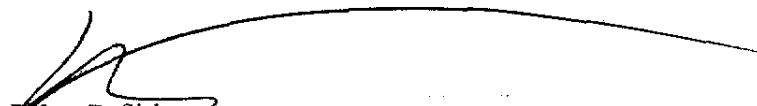

1. The name of this Corporation is Colococonnection, Inc. Its principal office address is 2601 South Bayshore Drive, Ninth Floor, Miami, Florida 33133.

2. Article I of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and amended to read as follows:

"ARTICLE I – NAME AND BUSINESS ADDRESS

The name and business address of this corporation is NAP of the Americas/West, Inc., 2601 South Bayshore Drive, 9th Floor, Miami, Florida 33133."

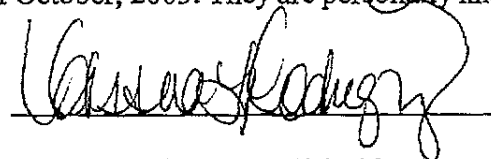
