**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of the corporation is Manasota Underwriters of Sarasota, Inc., and the principle address is:

**ARTICLE II - REGISTERED OFFICE AND AGENT**

**ARTICLE VI - AMENDMENTS**




