Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

First: Article I. Name is hereby restated as follows:

"ARTICLE I. NAME

Second: Except as set forth above, all other provisions of the articles of incorporation shall remain in full force and effect.
