ARTICLES OF INCORPORATION CLOSEOUTS 2000 STORE RETURNS & SALVAGE, INC.

coming a solution I, the undersigned, do hereby associate ourselves together for the purpose of becoming corporation under and pursuant to the laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of corporation for profit, and for that purpose, do hereby certify, declare and set forth as follows, to wit:

ARTICLE I

NAME: The name and address of this corporation shall be:

- D. To lend money to and use the credit to assist the officers and employees in accordance with Florida State sec. 607.141.
- E. To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligation of, other domestic or foreign corporations,

- F.
