ARTICLE I. CORPORATE NAME

The name of this Corporation is Cruver- Schoelles, Inc.

ARTICLE II. CORPORATE PRINCIPAL OFFICE AND MAILING ADDRESS


ARTICLE XI. PRE-EMPTIVE RIGHTS
