The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida .

ARTICLE I. NAME

The name of the Corporation shall be:

MATOS RESTAURANT, INC.

The address of the principal office of this Corporation shall be 2903 N. Nebraska Avenue, Tampa, Florida 33602, and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS

This Corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is 7,500 shares of common stock having no par value per share.

ARTICLE IV. REGISTERED AGENT

The street address of the initial registered office of the Corporation shall be 9119 Corporate Lake Drive, Suite 300, Tampa, Florida 33634, and the name of the initial registered agent of the Corporation at that address is Daniel F. Martinez, II, Esquire.

ARTICLE V. TERM OF EXISTENCE

This Corporation is to exist perpetually.

ARTICLE VI. DIRECTORS

All corporate powers shall be exercised by or under the authority of, and the business and affairs of the Corporation managed under the direction of its Board of Directors, subject to any limitation set forth in these Articles of Incorporation.
