ARTICLES OF INCORPORATION THE DATE

ARTICLE I

The name of the corporation is GRAPHIC VIDEO INCORPORATED

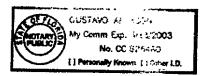

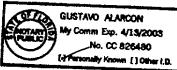
