ARTICLE I

CORPORATE NAME

The name of this corporation is THE INNOVATIVE SOURCE, INC., and its principal place of business shall be located at 619 SW 5<sup>TH</sup> Avenue, Delray Beach, FL 33444.

ARTICLE II

CORPORATE NATURE

This is a corporation that shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III- PURPOSES
