ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is: Dyrneed, Inc.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on the date of filing of these Articles.

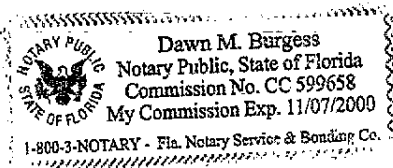
