In your letter, you note that this process cannot be completed until D.C.'s federal identification number is entered in block 5 of the reinstatement document. Additionally, you indicate that a specific statement with respect to the years for which uniform business reports were not mailed must be made and that our registered agent needs to acknowledge the designation in the space provided for it on the form.

In connection with your instructions, D.C. Whitfield's federal identification number has been added to the reinstatement form. For your record, business reports were not filed for the years 2001 and 2002. With respect to the registered agent acknowledgement, Mr. Robert Santorelli has passed away and, as such, cannot sign the reinstatement document. Accordingly, Douglas Whitfield has been appointed as the new registered agent and his signature appears on the appropriate line.

In connection with the new registered agent appointment, a registered agent change and transmittal form along with a check for \$35 are enclosed in this package.

The uniform business report for 2003 along with a check for \$150 is also enclosed. I request that you abate additional charges for filing the 2003 report after May 1<sup>st</sup> for the same reasons outlined in the above referenced abatement letter.
