ARTICLES OF INCORPORATION

I, the undersigned, hereby associate for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida providing for the formation of a corporation for profit.

ARTICLE I

Name and Principal Address

The name of the corporation shall be TREATZ - A BAKERY FOR DOGS AND CATS, INC., and the principal and mailing address of the corporation shall be 4539 Hanover Park Dr. Jacksonville, Florida 32224.

ARTICLE II

Duration

This corporation shall have perpetual existence.

ARTICLE III

Purpose

The general nature of the business to be transacted by this corporation is to do all things that are authorized to be done by corporations organized under the laws of the State of Florida.

ARTICLE IV

Capital Stock

The aggregate number of shares which the corporation is authorized to issue is one thousand (1,000) shares. Such shares shall be of a single class, and shall have a par value of one cent (\$0.01) per share.

ARTICLE XII
Corporation Business


