ARTICLE I - NAME

The name of this corporation is FIRST CLASS TRUCKING,  
INC. and the principal office or mailing address of the  
corporation is 2245 Whitehorse ~~Court~~ <sup>Street</sup>, Deltona, Florida  
32738.

ARTICLE II - DURATION

The corporation shall have perpetual existence  
commencing on the date of this filing of the Articles with  
the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting

incorporated under Chapter 607, Florida Statutes, as now  
exist or may be amended.


