ARTICLES OF INCORPORATION OF FIRST CLASS TRUCKING, INC.

ARTICLE I - NAME

The name of this corporation is FIRST CLASS TRUCKING, INC. and the principal office or mailing address of the corporation is 2245 Whitehorse Trucking, Deltona, Florida 32738.

ARTICLE II - DURATION
