Earl A. Duesel undersigned, being of the age of eighteen (18) years or more, does hereby make and acknowledge these Articles of Incorporation under and by virtue of the laws of the State of Florida.

1. The name of the Corporation is.S&T Consultants Inc.
2. The number of shares the corporation is authorized to issue shall be one thousand shares all of one class designated as common stock.
3. The principle place of business and mailing address of this corporation is c/o Earl A. Duesel 22 Royal Palm Way No. 503, Boca Raton Palm Beach County Florida. 33432 and the name of the initial registered agent at this address is Earl A.
