# ARTICLES OF INCORPORATION OF SOUTH THIRD STREET CORP.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

### Article I NAME AND ADDRESS

Section 1.1. Name. The name of the corporation is South Third Street Corp.

Section 1.2. <u>Address of Principal Office</u>. The address of the principal office of the corporation is 222 Ocean Front, Jacksonville Beach, FL 32250.

#### Article II DURATION

Section 2.1. <u>Duration</u>. This corporation shall exist perpetually. ## Article III PURPOSES

## Article IV CAPITAL
