ARTICLE I.

NAME

The name of the corporation is FORENSIC PSYCHOLOGY, P.A.

ARTICLE II.

NATURE OF BUSINESS

The general character or nature of the business to be to be transacted by this corporation is:

- (a) To provide professional psychological services to the general public including, but not limited to: counseling services and other forms of therapeutic intervention; psychological assessments and diagnostic evaluations; evaluation, measurement and assessment of intellectual ability, aptitudes, or achievement; group and individual psychotherapy; administering and evaluating psychological tests and other measurement instruments and other related forms of psychological services.
