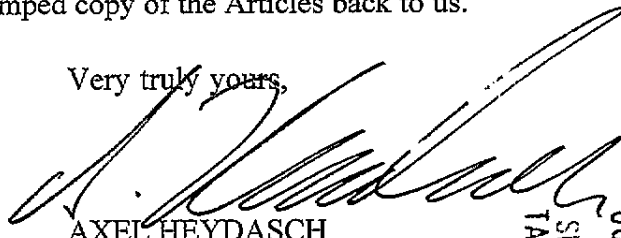

ARTICLE X. INDEMNIFICATION OF OFFICERS AND DIRECTORS

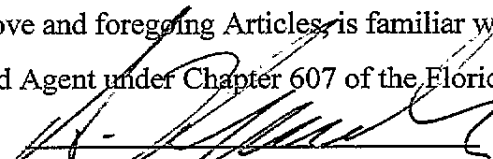
