ARTICLES OF INCORPORATION

The undersigned, acting as Incorporators of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

1. **Name.** The name of this corporation is A & V Construction Cleanup, Inc.
2. **Duration.** The period of its duration is perpetual.
3. **Purpose.** The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.
4. **Capital Stock.** The total number of shares of capital stock which the corporation shall have authority to issue is as follows:
 - (a) 100 shares of non-voting Preferred Stock having a par value of \$1.00 per share.
 - (b) 100 shares of voting Common Stock having a par value of \$1.00 per share.

5. **Initial Registered Office and Agent.** The name and address of the initial registered agent and office of this corporation is as follows:
