ARTICLE IV - CAPITAL STOCK

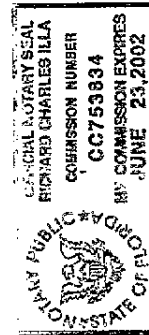

ARTICLE VI - INITIAL BOARD OF DIRECTORS

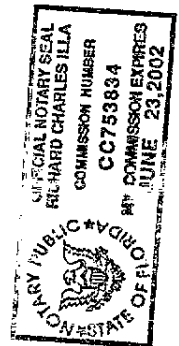

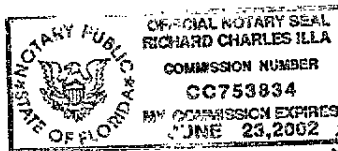
