I have just received this letter, today April 30, 2002. Three days before the due date.

The letter requests I correct the annual report/uniform business report. My signature did not match that which was on file as a current officer/director of the corporation.

I signed my name as Sam Johnson rather than as it is listed as the Director and President and Secretary. My legal name is Samuel Attaway Johnson. It has been recorded as S. Attaway Johnson, S. A. Johnson or Samuel A. Johnson on the corporate documents.

Since this very similar thing happened last year which almost caused the dissolution of my company, simply because the first letter requested a correction and a return mailing address. Followed by a second letter requesting a different correction (which could have been requested on the first letter, but wasn't) and a different return address. Both letters arrived with insufficient time to use regular mail.

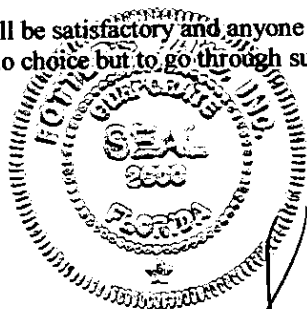
Therefore, I have corrected the copy of the annual report/uniform business report by striking thru the first signature, initialing the strike through, then resigning the form beneath the first signature.

I will also affix my corporate seal onto this letter and sign beneath the seal.

Unfortunately, I cannot mail this form with overnight delivery for 10 AM arrival Thursday May 2, 2002, to the address given, since it is a post office box. Therefore I will mail a copy using regular mail to the address on the letter (Division of Corporations, P.O. Box 1500, Tallahassee, Florida 32302-1500), the address listed at the bottom of the letter and on the website (Division of Corporations, P.O. Box 6327, Tallahassee, Florida 32314), and a third copy using FED-X courier overnight service to the address also listed in the website (Department of State, Division of Corporations, 409 E. Gaines Street Tallahassee, FL 32399)

I hope this will be satisfactory and anyone getting this memo will understand that these are duplicate documents. I feel I have no choice but to go through such redundant steps, at the risk of creating greater confusion.
