THE UNDERSIGNED, acting as sole incorporator of **STYLES INSURANCE FINANCIAL SERVICES, INC.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

Name

The name of the Corporation is **STYLES INSURANCE FINANCIAL SERVICES, INC.**

ARTICLE II

Corporate Purposes, Power, and Rights

The purpose of the Corporation is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III

Duration of the Corporation

Existence of the Corporation shall commence on the date all fees are paid and these Articles of Incorporation are filed by the Secretary of State and the Corporation shall exist perpetually unless dissolved according to law.

The corporation shall have two (2) director(s) who shall manage the corporation. The initial director(s) shall be:




