**Articles of Incorporation  
of  
MILLENUM BEGINNINGS, INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

**Article 1: Name.** The name of the Corporation is MILLENUM BEGINNINGS, INC.

**Article 2: Duration.** The duration of the Corporation is perpetual.

**Article 3: Purpose.** The general purposes for which the Corporation is organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

**Article 4: Capital Stock.** The aggregate number of shares which the Corporation is authorized to issue is 100 (One Hundred) shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 (One Dollar) per share. The initial Shareholder(s) is JOHN M SHAY and GERALDINE L SHAY and each shall retain 50% ownership of the stock.

**Article 5: Principal Office, Initial Registered Office and Agent.** The street address of the principal office of the Corporation is 2014 67TH STREET CT. E., BRADENTON, FL 34208 and the name of the initial Registered Agent and address is ENOLA H WOLFINGER, 4509 BEE RIDGE RD., STE. B, SARASOTA, FL 34233.

**Article 6: Initial Board of Directors.** The number of Directors constituting the initial Board of Directors is two. The number of Directors may be increased from time to time in accordance with the bylaws but shall never be less than 1 (One). The name and address of the initial directors of the corporation are as follows: JOHN M SHAY AND GERALDINE L SHAY, 2014 67TH STREET CT E, BRADENTON, FL 34208.

**Article 7: Incorporator.** The name and address of the incorporator is JOHN M SHAY, 2014 67TH STREET CT. E., BRADENTON, FL 34208.

**Article 9: Indemnification.** The Corporation shall indemnify each Officer and Director, including former Officers and Directors, to the full extent permitted by law.

**Article 10: Bylaws.** The power to adopt, amend and repeal Bylaws shall be vested in the Board of Directors, but all alterations, amendments and repeals of the Bylaws must be approved by a majority of the Shareholders.
