ARTICLES OF INCORPORATION
OF

The undersigned adopts the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be Florida Keys Rental Properties, Inc..

ARTICLE II - COMMENCEMENT & DURATION

The corporation shall commence its existence on May 1, 2000 and shall exist perpetually unless sooner dissolved according to law.

The Directors shall have the power to amend or repeal these Articles of Incorporation with not less than a two-thirds vote of the common stock.


