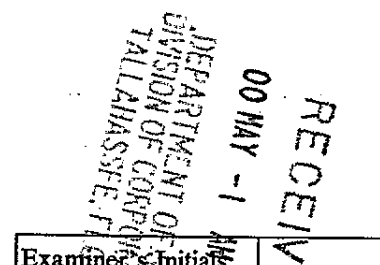

**ARTICLES OF INCORPORATION**

*Initial issue:* 100 shares of the Capital Stock of the Corporation shall be issued for adequate consideration in the following manner:

*Dividends:* The holders of the outstanding capital stock shall be entitled to receive, when and as declared by the Board of Directors, dividends payable either in cash, in property, or in shares of the capital stock of the Corporation.



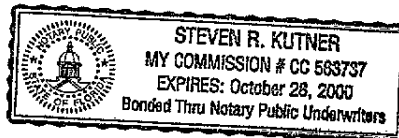
